### Q. What type of exams are the QuickBooks Certified User exams?

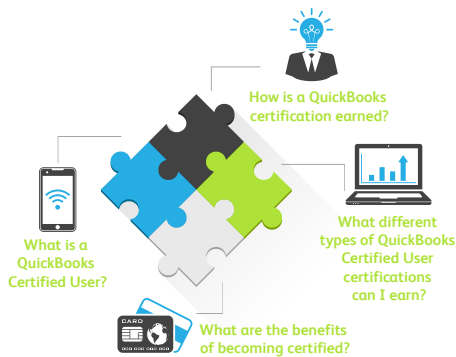

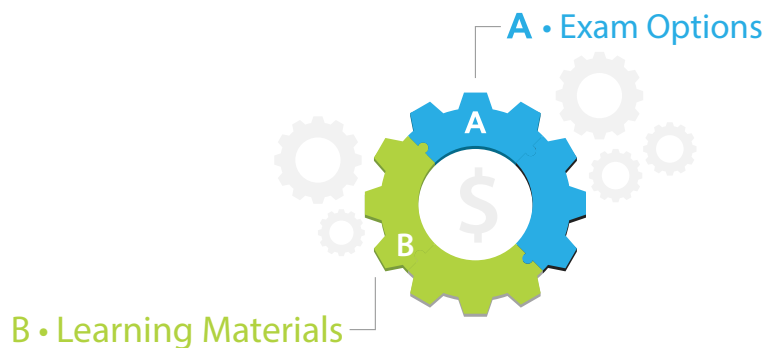
